Workshop 1:

Heart Failure

Workshop description

Heart failure (HF) is a growing global public health problem affecting at least 26million people worldwide. The evidence-base for HF treatment has changed rapidly over the last 30 years. Despite these recent advances in therapy, HF is still a malignant condition with poor outcomes and quality of life. HF treatments depend on the type of HF the patient has: HF with reduced ejection fraction (HFrEF) if EF<40%, mildly reduced (HFmrEF) if EF 41-49% and preserved (HFpEF) if EF >50%. Through two interactive case studies, this workshop will focus on the pharmacological treatment of HF

Learning objectives

- Understand the importance of optimal use of guideline-directed pharmacological treatments for HF.
- Understand where the role of the pharmacist may be utilised to improve the treatment of HF

Workshop 2:

Mental Health Pharmacogenomics

Workshop description

This workshop will teach participants about different forms of genetic variation and how these can impact the efficacy and safety of a medicine. It will cover various methods of genetic testing; describing their strengths and limitations. Participants will be shown how to use various databases and resources to interpret how a genetic variant may affect a medicine and signposted to guidelines and training resources for further development.

A base level understanding of DNA, genetic terminology (nucleotides, RNA, chromosomes etc) and inheritance is required.

Learning Objectives:

- To understand key concepts about genetic testing and the interpretation of genetic variation.
- To understand how gene variants can affect medicines outcomes.
- To be aware of the guidance, databases and resources that can help with pharmacogenomic queries.
- To be aware of National Genomics Strategies and further training opportunities for pharmacy professionals

Management workshop - Staff Motivation and Retention

Workshop 4:

Simulation based training applications in clinical pharmacy - an introduction to theory, applications and design.
Aim of workshop / Brief description This session provides an introduction to the concepts of simulation-based training including benefits and applications in healthcare. The session will also help participants to understand what they need to know and do to design and deliver successful simulation-based training.
Learning objectives: <ul style="list-style-type: none">• Describe the benefits of simulation-based training to clinical practice.• Outline potential areas of their working practice that could be supported by simulation training.• Describe common barriers and enablers to simulation training.• Describe how to plan, prepare and design a simulation training session.• Outline the importance and processes of a simulation debrief.

His main research interests focus on safe prescribing and how healthcare professionals learn to prescribe and learn from error, and how educational interventions such as simulation-based training can help prescribers to develop their competence. <u>Mark Rowson</u> is the Head of Simulation at Mersey and West Lancashire Teaching Hospital NHS Trust. He is the regional Simulation Lead for Higher schools of Medicine for Mersey and Cheshire. Mark has experience in Neonatal, Paediatric, Adult and Obstetric simulations with a special interest in in-situ simulation exploring ergonomic error causation.

Paediatrics
Workshop description Sixty percentage of children are treated in hospitals outside CHI Crumlin, Tallaght and Temple Street. This workshop is an introduction for pharmacists in general hospitals to clinical review of paediatrics patients.

Introduction to Systematic Reviews
Workshop description Systematic reviews can be enormously beneficial in gathering, organising, and assessing data in a rigorous manner to help inform pharmacist clinical decision making. The complexity of a full systematic review can make starting one appear daunting. This workshop will give a practical overview of systematic reviews and provide tips on addressing common issues when conducting them. The mix of theory and hands-on practice in this workshop will complement each other to increase confidence in overcoming obstacles and knowing where to find helpful tools if necessary. This workshop will also benefit those who rely on information from literature reviews in their daily work as they will gain a better appreciation of reviews' strengths and gaps.
